

Mila's story

Mila is alive today because someone like you chose to help. A gift in your Will could change everything for a child like Mila.

Tracey and Steven are first-time parents to their beautiful daughter Mila. At just 16 months old, Mila was diagnosed with a severe form of epilepsy. Her seizures, including nocturnal-tonic seizures, strike suddenly and without warning, often while she sleeps.

After urgent medical consultations with both Starship and Waikato Hospital, Tracey and Steven were told that Mila was at high risk of SUDEP – Sudden Unexpected Death in Epilepsy. It was every parent's worst fear: the possibility of losing their baby girl in the middle of the night.

Could you imagine being told your baby might pass away in the night?

To give Mila the best possible care, the young family moved towns to be closer to emergency services. It came at a huge financial cost, and they quickly found themselves struggling to afford the one device that could keep her safe

– a specialised seizure detection mat, costing \$1500.

Thanks to the generosity of donors who support Variety, Tracey and Steven were able to receive this life-saving piece of equipment for Mila.

Since then, the mat has detected eight seizures. Eight moments that might have ended very differently without that early warning.

"This mat is helping Mila live," Tracey told us. "As first-time parents, we're able to get a better night's sleep knowing we have this support."

Mila's journey is ongoing. Her seizures affect her strength, her development, and her vision. But because someone made the choice to give, she now has a safer start in life, and her parents have the support they so urgently needed.

"When people tell me they are thinking about leaving a gift in their Will to Variety, I say go for it... absolutely do it. You've got the opportunity to do something wonderful for kids who need your help. There are four main types of gifts

Your legal adviser can help you choose the one that best fits your circumstances:

- Residuary gift the remainder of your estate after debts and specific gifts have been distributed.
- 2. Percentage gift a nominated fraction of your estate (e.g. 5%).
- 3. Specific sum or asset a fixed amount of money or particular asset such as shares or property.
- **4. Specified bequest** a particular item of value, such as stocks, shares, property or art is gifted in your Will.

We recommend you speak with a solicitor or qualified advisor when updating or writing your Will.



Here is suggested wording you can include:

"I bequeath [___% of my residual Estate / the sum of \$___ (choose one option)] to Variety – the Children's Charity Incorporated New Zealand for its general purposes. A receipt from an authorised officer of Variety is sufficient release for the executors of the Estate without seeing to the final distribution of the funds."

Providing this wording to your lawyer makes the process straightforward and ensures your wishes are clear.

Frequently asked questions

Do I need to rewrite my whole Will?

Usually not. Your lawyer can simply add a codicil containing the wording above. If you are writing your Will through the platform, Gathered Here, you will have to rewrite your Will. This process is so simple, and takes 10 minutes.

Can I change my mind?

Absolutely. Your Will is entirely yours, and you can amend it at any time.

Will my gift be kept confidential?

Yes. We respect your privacy and will only acknowledge your gift publicly with your permission.

What if I have a Family Trust?

Most Trusts must be wound up within 80 years, so you can still leave a legacy by including Variety as a final beneficiary or through your personal Will.

Why tell Variety?

Knowing about your intention helps us plan for future programmes and, most importantly, thank you during your lifetime.

We promise to:

- Respect that your decision is private and personal, and treat it as such
- Recognise and understand that your family and loved ones come first in your Will
- Not put you under any pressure. This is your decision to make, on your time and consideration
- Understand that circumstances change and that you may change your mind about leaving a gift in your Will to Variety
- Keep your personal data safe and never pass it on to third parties

- Make sure any gift in your Will to Variety will be handled with utmost respect, and used to accomplish our mission of giving children in need across New Zealand the childhood they deserve
- Use your gift carefully to ensure it achieves the greatest possible impact for the children we will be working with
