Ticket Information: Each Ticket costs \$30 NZD and includes GST. The total number of tickets available in the Variety car raffle is 12,000 ranging from ticket numbers 00001 to 12000 inclusive. Tickets are only available to purchase online at the ticket platform via credit card (Mastercard, Visa, AMEX). A current email address and phone number must be provided to participate as all tickets will be issued by email, and the winner will be contacted via phone.
